Petty politicians out to subvert land-use in Masterplan

ITH a month left for the Supreme Court to hear the matter regarding shifting of non-conforming "industries" from areas they are illegally occupying, suddenly all shades of politicians are crawling out of the woodwork, kicking and screaming in the same voice.

Sibal is mentioning the possibility of an ordinance; Khurana tearfully tells us how he tossed and turned on the Raj Bhawan bed (four times a week he needed sleeping

pills); Maken wants Masterplan changes; and Dikshit scurries off to meet the PM. The list is long.

What is all this hullabaloo about? Just a few odd workshops which are operating illegally? Yes, these are not industries. There are no Bajajs, Hondas, Tatas, Birlas, Bhartis or HLLs operating here. These are some small-scale units which have been helped by our petty politicians to set up shop next door and pollute what are primarily residential areas.

The Supreme Court has not asked the Delhi government to close legal industrial

areas — Okhlas, Wazirpurs, Lawrence Roads and others. All that it is saying is respect land-use regulations and shift the units operating illegally to planned industrial estates.

Is there any shortage of legal industrial estates? No, we have plenty around the Capital. Rajasthan has Bhiwadi, Bhawal, Alwar. And Haryana has a string of them. Faridabad has lots of empty industrial land and so does Sonepat etc.

Even for food products, the excellent road network which NHAI has built ensures that your curd comes from Philakwa, bread from Ludhiana, atta from Ambala.

The crux of the matter is that land-use regulations are the backbone of any town planning law and regulatory system in a city, and allowing illegal land-use to be "regularised" — even under an or-

dinance — will amount to violation of Delhi Development Authority Act. The second issue is that the Act is a Central enactment, not a state law.
